In connection with your request, we have reviewed your Implementation Conformance Statement (ICS), referred to as IDN.IDE.EMRTD.2020-003 and we have assessed your Test Reports (references: IC.E.RE.2001.013_v1.0 (Analog extension), IC.E.RE.2001.014_v1.0 (Analog), IC.E.RE.2001.015_v1.0 (Digital), IC.E.RE.2001.016_v1.0 (Application)) generated by the laboratory ICUBE, following the Test Plans "ISO 18745-2: Part 2", "ICAO TR- RF Protocol and Application test standard for eMRTD - PART 3" and "AFNOR/BSI TR-03105 – Extended Access Control (EACv1) .

After assessing such files in the Certification Evaluation Report (ref.
