In connection with your request, we have reviewed your Implementation Conformance Statement (ICS), referred to as IDN.BIT.EMRTD.2023-017 dated 13/09/2023 and we have assessed your Test Reports (references: IC.E.RE.2307.015_v1.0 (Dimension/Analog), IC.E.RE.2307.016_v1.0 (Analog), IC.E.RE.2307.017_v1.0 (Digital), IC.E.RE.2307.018_v1.0 (Application)) generated by the laboratory ICUBE Testing Center, following the Test Plans “ISO 18745-2: Part 2”, “ICAO TR-RF Protocol and Application test standard for eMRTD - PART 3” and “AFNOR/BSI TR-03105–Extended Access Control (EACv1)”.

After assessing such files in the Certification Evaluation Report (ref.
